SEP 2016: Invitation to bid for 2017-2021 events sent to National Federations.

1st NOV 2016: Letter of Interest and Application Form by National Federations to be sent to the ICF HQ

1st FEB 2017: Deadline for Bid Documents to the ICF HQ and respective discipline Chairman

# **Phase II Evaluation**

**NOV 2016**– **FEB 2017**: Visit by ICF HQ and/or Technical Visit BY ICF Chair if ICF not familiar with the venue (Optional). If ICF needs to visit the Bid Committee, the costs are paid by the NF bidding.

MAR 2017: Report on Operational Aspects of Bid Document by ICF HQ

MAR 2017: Report completed by ICF Chair

MAR 2017: Final Report and Evaluation prepared for Board Members

#### **Phase III Decision**

MAR 2017: Board Decision for 2019-2021 World Cups and World Championships April/May 2017: Confirmation letter to Host of the next World Championships including recommendations or adjustments to the bid
