Murau is good accessible by train and by car. The sprint course is located in the center of Murau, the classic course is located 20 km upstream of Murau between Ramingstein and Predlitz.

Mur is a natural river. The sprint-course is located in the old city of murau 1 minute from main sqaure, very good for spectators. The course is 400 meters long, grade 1-3. The classic course is located between Ramingstein and Predlitz, 6 km long, grade 2-3, there are some bridges and good places for spectators.
